Eligibility Criteria	
1.	The Applicants / Bidder may be a Proprietary firm /Partnership firm / Limited Company / Corporate body legally constituted etc.
2.	There should be no case pending with the police case against the Proprietor/Firm/Partner or the Company as a whole (Applicants / Bidder) shall not have been blacklisted by any Government Departments, Public Sector Companies, Banks and Government Autonomous organizations.
3.	The Applicants / Bidder should be registered with PWD or equivalent, Income Tax and GST Tax
4.	Experience/ Work done Certificate: The Bidder Should have Completed successfully at least one similar type of work.

- The Contractor / Bidder must visit to the site, mention in above tender work and same site visit form duly signed by Engineer In-charge should upload with the documents.
- The bidder shall upload documents showing qualification information, as follows
 - Total monetary value of each work performed for each year of the last 3 years, exceeding estimated cost of present work.
 - Income tax clearance certificate from the concerned IT circle or IT Return forms;
 - GST Registration certificate.
 - Details of any litigation, in which the bidder is involved, the concerned parties and disputed amount in each case.
- Bid Price**
 - The contract shall be for the full work as described above. Corrections, if any, shall be made by crossing out, initializing, dating and re writing in words.
 - All duties, taxes, GST and other levies etc. as applicable are payable by the bidder under the contract and shall be included in the total price.**

 - c) Any conditional Tender will not be accepted and quantity of the items may vary as per requirement at the time of execution of the work.
- 8 The Owner will award the contract to the Bidder whose Tender has been determined to be substantially responsive as per the terms and conditions.
- 9 Notwithstanding the above, the Owner reserves the right to accept or reject any Tenders and/or to cancel the bidding process and/or reject all Tenders at any time prior to the award of contract.
